SECTION 4: First aid measures

4.1. Description of first aid measures

General information

Remove contaminated soaked clothing immediately.

If you feel unwell, seek medical advice.

After inhalation

Move to fresh air in case of accidental inhalation of vapours or decomposition products. Refer for medical treatment.

After contact with skin

Wash off with soap and plenty of water. Consult a doctor if skin irritation persists.

After contact with eyes

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Seek medical treatment by eye specialist.

After ingestion

6.1. Personal precautions, protective equipment and emergency procedures

In case of vapour formation use respirator. Ensure adequate ventilation. Use personal protective clothing. Keep away sources of ignition.

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder). Shovel into suitable container for disposal.

Appropriate engineering controls
